## Certification of Inability to Operate Due to Lack of Quorum

In accordance with the Executive Proclamation 29 JBE 2021 issued by Governor John Bel Edwards on March 2, 2021, Louisiana Revised Statutes 42:17.1 and concurrence by the Attorney General on March 19, 2020, this notice shall serve as certification of the French Market Corporation's inability to otherwise operate in accordance with the Louisiana Open Meetings Law due to a lack of quorum as a result of the COVID-19 public health emergency. Therefore, in accordance with 29 JBE 2021 and LA R.S. 42:17.1, the French Market Corporation's meeting on March 25, 2021, at 11:45 AM will be held via video/ telephone conference and in a manner that will allow for observation and input by members of the public, as set forth in the notice posted on March 22, 2021.

All other Open Meetings Law requirements have been met.
